

eToro UAE Sign Up and Enter to Win Promotion 2026

(the "Promotion")

These Terms and Conditions (the "**Promotion T&Cs**") govern the Promotion conducted by eToro (ME) Ltd. ("**Us**", "**We**", "**Our**", "**eToro**"). Promotion Description:

During the Promotion Period, Eligible Participants who open a new eToro Account and meet the Qualifying Terms will receive a stock airdrop of Qualified Stocks credited to their eToro Account on the Bonus Date (as such term is defined below), based on their total deposits during the Promotion Period (the "**Welcome Bonus**").

In addition, Eligible Participants who deposit US\$500 or more will be entered into a draw for a chance to win Apple AirPods Pro 3, and Eligible Participants who deposit US\$2,000 or more will be entered into a draw for a chance to win an Apple iPhone 17 Pro Max (256GB) (the "**Physical Prize Draw**"). Full details of both the Welcome Bonus and the Physical Prize Draw are set out in Sections 2 and 3 below.

This Promotion begins at 00:00 am (GST) on May [6], 2026 ("**Start Date**") and ending at 23:59 pm (GST) on June [5], 2026 (the "**End Date**", such period being the "**Promotion Period**").

1. The Qualifying Terms

Any individual who meets all of the following qualifying terms may participate in the Promotion (the "**Qualifying Terms**", and an "**Eligible Participant**", respectively):

- (a) be a resident of the United Arab Emirates;
- (b) complete the registration to open an eToro trading platform account (an "**eToro Account**") during the Promotion Period, which is subject to our approval;
- (c) not be an existing eToro customer with an eToro Account and not be a customer whose eToro Account has been closed within the past 30 days;
- (d) have his/her eToro Account **fully verified** by completing his/her profile pursuant to eToro procedures and policies;
- (e) make deposit(s) totaling a minimum of US\$200 to its fully verified eToro Account, at any time during the Promotion Period. Such deposited amounts must remain in your eToro Account for a minimum of 90 days. It being clarified that all deposits made to your eToro Account during the Promotion Period shall count towards the eligibility of the Welcome Bonus and the Physical Prize Draw;
- (f) NOT be an employee of eToro or of an eToro subsidiary, parent company or a company under common control with eToro ("**eToro Affiliates**") and NOT be an immediate family (parent, sibling, spouse, child) or household member of an eToro employee, an employee of an eToro Affiliate, or a person involved in any part of the administration and execution of this Promotion; and
- (g) NOT be involved in any part of the administration and execution of this Promotion.

2. The Welcome Bonus:

- (a) Each Eligible Participant will automatically receive Qualified Stocks as a Welcome Bonus based on their total deposits during the Promotion Period, as follows:

- (b) As part of the registration process, you will be offered to select a stock from a list provided by us that you would like to be added to your eToro Account for free (the “**Qualified Stocks**”). Please note that the availability of Qualified Stocks is subject to local regulatory restrictions and may vary.
- (c) The Qualified Stocks presented to you may be subject to change. The inclusion of an asset on the list of Qualified Stocks is not an investment recommendation or endorsement of such investment by eToro.
- (d) The Welcome Bonus is expected to be added to your eToro Account within 7 days after you have fully met the Qualifying Terms set forth above, but there may be situations when this process takes longer (“**Bonus Date**”).
- (e) As part of the Promotion, eToro will buy a certain amount (based on the total deposits set forth in the table above) of the Qualified Stocks that you select. However, the purchase of Qualified Stocks will be subject to eToro’s fees and so the amount you ultimately receive is expected to be lower than such amount. Any future sale or transfer of the Qualified Stocks on eToro’s platform will be subject to the corresponding fees and will be subject to the governing eToro terms and conditions.
- (f) We reserve the right, at our sole discretion, to provide you, on the Bonus Date, in lieu of the Welcome Bonus, any alternative bonus having the same value as the Welcome Bonus, including but not limited to, a cash deposit or alternative Qualified Stocks.

3. **Physical Prize Draw**

- (a) In addition to the Welcome Bonus, Eligible Participants whose total deposits during the Promotion Period amount to US\$500 or more will be automatically entered into the Physical Prize Draw as follows:

- (b) For the avoidance of doubt, all deposits made by a participant during the Promotion Period will count towards their total deposit amount and draw entry allocation. The maximum number of draw entries per Eligible Participant is 5, regardless of the total amount deposited.
- (c) The Physical Prize Draw consists of two (2) separate draws: (a) one (1) draw for the Apple AirPods Pro 3, from which four (4) winners will be selected; and (b) one (1) draw for the Apple iPhone 17 Pro Max (256GB), from which four (4) winners will be selected. Each Eligible Participant may win only one (1) Physical Prize.
- (d) eToro will conduct the Physical Prize Draw no later than June [18], 2026 (the “**Draw Date**”). Winners will be selected randomly and notified by email within 7 days of the Draw Date (the “**Announcement Date**”). The results as recorded on eToro’s records and systems

shall be deemed final and binding on all Eligible Participants. The names of winners will be announced via eToro's social media channels following the Announcement Date.

- (e) Winners will receive an email within 24 hours of the Announcement Date with instructions on how to redeem their Physical Prize. Winners will be invited to attend a lunch event at eToro's offices in Abu Dhabi, which will include a presentation by eToro, following which each winner will receive their Physical Prize in person. Winners must confirm their attendance within 15 days of the email being sent, after which the Physical Prize will be forfeited. The date, time and further details of the lunch event will be communicated to winners by email. eToro shall not be responsible for any travel or accommodation costs incurred by winners in connection with attending the lunch event.
- (f) In the event that a winner is unable to attend the lunch event, the winner shall provide a valid shipping address within the United Arab Emirates, and the Physical Prize will be delivered to the winner within 30 days following the date of the lunch event. eToro shall not be responsible for any shipping delays, customs fees, taxes, or other charges associated with such delivery. Delivery of Physical Prizes is available only to addresses within the United Arab Emirates.
- (g) Physical Prizes are not transferable. A winner may not designate another person to receive a Physical Prize on their behalf or to attend the lunch event in their place. Physical Prizes are subject to availability and may be subject to additional terms and conditions at the time of delivery.
- (h) By entering the Promotion, participants consent to the publication of their name, country, photograph, and likeness via eToro's social media channels, website, and marketing materials, in the event they are drawn as a winner. By attending the lunch event, winners further consent to being photographed and/or recorded, and to eToro's use of such photographs and recordings for promotional and marketing purposes. - (i) eToro reserves the right, at its sole discretion, to substitute any Physical Prize with an alternative prize of equivalent value, including a cash equivalent.

4. What Other Conditions Am I Agreeing to by Entering?

- (a) By entering the Promotion, all entrants will be deemed to have accepted and agreed to be bound by these Promotion T&Cs, as well as the eToro documents referenced in the introductory paragraph of this document.
- (b) In any case of contradiction between these Promotion T&Cs and any Promotion Publication (including emails, push notifications, banners, newsletters or other communications sent by eToro or any party acting on its behalf), these Promotion T&Cs shall prevail unless specifically stated otherwise within such Promotion Publication.
- (c) Eligibility to participate in this Promotion is limited to one account per person/household. Participants with more than one eToro Account will be eligible for one reward only. In the event a user submits more than one promotion application, only the first application submitted will be considered. Users opening or operating multiple accounts to benefit from this Promotion will not be entitled to receive any reward.
- (d) If an Eligible Participant closes his/her eToro Account, that participant will forfeit their right to receive the Welcome Bonus, to participate in the Physical Prize Draw, and, if already drawn as a winner, to claim the Physical Prize. - (g) If any participant attempts to compromise the integrity or legitimate operation of this Promotion through fraud, manipulation, or the provision of false details, eToro may seek damages from such participant to the fullest extent permitted by law, refrain from granting rewards, deduct any amounts already granted, and/or ban such participant from future eToro promotions.

- (h) If eToro suspects that a user (whether alone or in concert with others) has manipulated or abused the Promotion or acted in bad faith or in a fraudulent manner, eToro reserves the right, at its sole discretion, to: (i) temporarily or permanently block, suspend or terminate the services under such user's eToro Account and close that account; (ii) remove or deduct any benefit granted to such user; (iii) remove or deduct any profits gained as a result of such manipulation or abuse; and/or (iv) deny, withhold or withdraw that user from this and any future promotion.
- (i) Users who have acted against the eToro Community Guidelines after being warned for any reason, and/or have been blocked from eToro websites, will not be entitled to receive any reward.
- (j) eToro reserves the right to cancel, terminate or suspend this Promotion at any time. Cancellation, termination or suspension shall not entitle any participant to any claim or compensation against eToro for any losses or damages suffered or incurred as a direct or indirect result.
