



## 0% Commission Stocks Pre-launch Competition: Terms and Conditions

### Competition period

The competition starts at 12.00 p.m. (GMT) on March 20, 2019 ("**Start Date**"), and ends at 00.00 a.m. (GMT) on May 7, 2019 ("**End Date**").

### The Competition

eToro will be giving five people the chance to win £10,000 to invest in stocks and shares on the eToro platform (Terms and conditions as defined below apply).

To enter the competition a person must simply enter their email address, first and last name on the promotional landing page. Once submitted, the entrant will be

1. added to a waiting list to be amongst the first to know when eToro launches the 0% commission on stocks and,
2. automatically entered into the competition.

Each entrant will subsequently have access to a personalised link which can be shared with friends, family and colleagues. For every friend, family member or colleague that joins the waiting list from the entrant's personalised link, the entrant will move up one position in the queue.

On the competition End Date at 10am, the three entrants at the top of the waiting list will win. Two other winners will also be randomly drawn from entrants whose waiting list position is an **even number**.

### Can I enter?

1. This competition is available for 'New Customers' only. 'New Customers' are defined as users who have not made a deposit on the eToro platform prior to the Start Date as defined above.
2. Entrants must be 18 years or over.
3. Entrants must be UK residents.
4. Entrants must submit their entry themselves.
5. Entrants are not required to open an eToro account to enter the competition, however in the event of the entrant winning, the entrant will be required to open an account to receive the prize subject to eToro's [Terms & Conditions](#) and every verification process as required by eToro.

6. 4. Subject to account opening and verification, each winner will win £10,000 to be added to an eToro account opened by the Winner (the “**Prize**”).
